How to Obtain Access to Course Materials, Quizzes and Examinations

All students must register for access to the P-Cubed Program using the registration link towards the bottom of the College's home page. Students will use their own current Howard University Student ID Number (with the @ sign) and their created password to gain access to the P-Cubed Program Course Materials and discussions. Additional information may be sent via email on an as-needed basis.

Text Books:

All required textbooks for the P-Cubed Program Course will be available via Access Pharmacy www.accesspharmacy.com. In addition, students will be given links to several helpful videos via www.youtube.com.

Quizzes

Each week, students will receive a small, short-answer quiz to stimulate further thinking and discussion on key topics. The quizzes will be administered via SurveyMonkey and can be taken at the student's leisure using the SurveyMonkey links available through Blackboard Collaborate or the link will be e-mailed to students. It is strongly encouraged to complete the quizzes in a timely manner—the questions will be designed to clear up common areas of confusion and the student will benefit greatly from the exercise. In addition, weekly online video tutorials will focus on these quizzes and further clarification of the questions they produce.

Grade System

The P-Cubed Program Course is not for credit and attendance is not mandatory however STRONGLY encouraged to assist with your IT coursework in Spring 2018. Quizzes and examinations will be administered for edification purposes, as well as allowing students to gauge their retention of information.
