How to Obtain Access to Course Materials, Quizzes and Examinations

The PBP Course Portal is available on the main page of the College of Pharmacy website at www.pharmacy.howard.edu. All registered students will use their own current Howard University Student ID Number (with the @ symbol) as a username and "COP2016!" (do not use the "" symbols) as a password to gain access to the PBP Online Course Portal.

Quizzes

Each week students will be quizzed on lecture materials and readings in an effort to gauge their abilities to acquire and assimilate new knowledge. ***Quizzes will be offered through Exam Soft ONLY, on Tuesdays and Thursday at 6:00PM EST.*** Students who using this course as a condition of their admission must complete all quizzes as scheduled. Missed quizzes will disqualify students to fulfill their PBP requirement.

- Tuesday Quizzes (will cover material taught Monday)
- Thursday Quizzes (will cover material taught Tuesday-Wednesday)
- To be eligible to take a quiz, 85% of the lecture must be attended or viewed online

Please refer to the PBP Schedule for the tentative quiz dates and times.

Examinations

Each week students take an exam which will be offered either on Monday or Friday following a weeklong lecture in a specific subject matter. ***Examinations will be offered through Exam Soft ONLY, on Mondays at 9:00AM EST or Fridays at 1:00PM EST.*** Conditional Admission students must take the examinations onsite, in the College of Pharmacy Computer Laboratory. In-Person students will be allowed access to the College of Pharmacy Computer Laboratory, in the event that they do not have a laptop computer available for their use. ***(Please Note: Conditional Admission students will be granted priority for the use of the College of Pharmacy Computer Laboratory on Examination and Quiz days).*** All in-person Students who are considering using this course a condition of their admission must complete all examinations as scheduled. Missed examinations will disqualify students to fulfill their PBP requirement.

- Monday and Friday Examinations (will cover material taught Monday-Friday)
- To be eligible to take an examination, 85% of the lecture must be attended or viewed online

Make-Up Examinations or Quizzes

Make-Up quizzes or examinations will ONLY BE OFFERED due to Howard University network failure during the designated quiz/examination date and time. On such occasion students will be notified of the make-up quiz and exam dates within 24 hours of the malfunction.

A student who fails to take the examination or quiz on its scheduled date and time shall earn the grade of "zero" unless his/her absence is considered "excused" as explained below. An absence from an examination or quiz shall be considered "excused" in the following circumstances:

- (a) Hospitalization of the student due to illness or accident
- (b) Death in the student's immediate family (e.g., spouse, parents, guardians, siblings and/or children).
- (c) Summon of the student to appear for Jury Duty or before a court

In these cases, the absentee student shall submit the supporting documents (Hospital Admission Form, Death Certificate or Government/ Court Subpoena) to the Course Coordinator. Upon satisfactory verification, the student may be allowed to take a makeup exam. **NO OTHER EXCUSES WILL BE ENTERTAINED FOR A MAKE-UP EXAM.**

Grade System

- All examinations including the comprehensive examination count toward the final grade
- Each quiz will be based on materials covered during a specified period and are not comprehensive to date of the examination.
- The final examination will be comprehensive and based on all lecture materials covered throughout the teaching period. All students must take the final examination and the two quizzes in each course.

*Any student absent for two lectures will receive 2% for class attendance; 3 absences will receive 1% for class attendance; 4 or more will receive 0% for class attendance.

Grading Scale

75% or above	=	Pass (75-100 points)
74% or below	=	Fail (74-0 points)

Quiz/Exam Results

ExamSoft is the software being used to administer quizzes and examinations. Quiz and Examination Results will be released within 24 hours via ExamSoft. ExamSoft Login and password are needed to access quiz/examination results.

Final Course Grade Distribution

Student will be notified of their final course grade (week long course) within 24 hours of taking the final. Results will be sent via e-mail. The final grade for the 5-week program will be sent via e-mail the week of August 8, 2016.

Passage of the PBP Program:

For students who are taking this program as a condition, to gain full admission for Pharmacy Biomedical Preview Program a student must get at least 75 % in each of the subjects and the average mark for all the subjects should be 75% or higher.
